## Terms and Conditions of Agreement

This is an agreement made \_\_\_\_\_(Date), between THE DON VELLER SEMINOLE GOLF COURSE and the organization indicated on the front of this document.

Tee times on the date of this tournament will not be reserved on the tee sheet until a deposit in the amount of \$\_\_\_\_\_ is received along with a signed copy of this contract. The deposit is non-refundable unless a written cancellation is received at least 30 (thirty) days prior to the date of the tournament.

### RESPONSIBILITIES:

1. Payment in full must be received no later than 3 (three) days before the tournament. Refunds (other than 14-day cancellations) will not be made except when the course is officially closed by management due to weather.
2. In order to receive a tax exempt status, a copy of the tax exempt certificate must be provided when payment is due.
3. Any damage to the golf course, cart fleet, clubhouse and/or property due to the misconduct by the participants of this tournament will be paid for by the organization/company hosting the tournament.
4. All food and beverage must be purchased and arranged through The Renegade Grill. Absolutely NO Alcoholic beverages may be brought on to SEMINOLE GOLF COURSE Alcoholic beverage MUST be purchased on site at regular prices.
5. Tournament players must observe the dress code and all prevailing rules and regulations covering the use of the course and clubhouse.
6. Management reserves the right to fill incomplete starting times for the day from the daily tee Sheet unless the course is being purchased by the ½ day.
7. Management reserves the right to refuse service to any participant that is currently under suspension from the club.
8. SPONSOR SIGNS - are the responsibility of the tournament committee. The committee may put signs on the course after 3pm the day before the tournament. Signs must be removed by the committee following the play of the tournament. Signs left on the course will be removed by the maintenance crew and thrown away.
